The story goes, apocryphal perhaps, that one day the Ugandan dictator, Idi Amin, told his foreign minister that the country's name must be changed to Idi and he should inform the UN and all other international bodies. A week passed. President Amin then summoned the minister and asked, 'Did you carry out my orders?' He replied saying that there was a problem. 'What problem?' the president inquired. 'Your Excellency, there is a country called Cyprus. The people are called Cypriots. If Uganda were to be called Idi, we would be called Idiots'. There are few leaders that K. Natwar Singh, in a diplomatic career spanning more than three decades, has not known and fewer still about whom he has no story to tell. In Walking with Lions: Tales from a Diplomatic Past, Singh puts together fifty episodes that entertain, inform and illuminate. Featured here is Indira Gandhi as a statesman and friend, alongside other renowned figures such as Fidel Castro, Haile Selassie and Zia-ul-Haq. Singh analyses some personalities with disarming candour, among them Morarij Desai and Lord Mountbatten, at other times, his admiration for leaders like C. Rajagopalachari and Nelson Mandela shines through. In these pages you will also find a rare, fascinating glimpse of Godman Chandraswami and his cohort Mamaji and their interaction with a surprisingly submissive Iron Lady Margaret Thatcher. Besides, there are short tributes to artists, writers, cricketers and film stars, like M.F. Husain, Nadine Gordimer, Don Bradman and Dev Anand. Recounted with empathy and humour, this collection of stories from contemporary history is a warm, unaffected and reassuring reminder that the great too can be as fallible as the rest of us.



10 Mcmahon Line: A Century of Discord/ Singh, J.J. - Harper Collins Publishers, Noida, 2019; xix, 441p.

Henry McMahon, a British colonial administrator, drew a line along the Himalayas at the Shimla Convention of 1913-14, demarcating what would in later years become the effective boundary between China and India. The boundary, disputed by India's northern neighbour, has had a profound effect on the relations between the two Asian giants, resulting prominently in the war of 1962 but also in several skirmishes and stand-offs both before and after that. It continues to be a thorn in the side - reaching a flashpoint at the tri-junction between Tibet, Sikkim and Bhutan in Doklam in 2017 - and may derail all the progress in bilateral ties if left unattended.



It examines the critical role that the private sector must play in these challenges. To transform the global energy complex to be carbon neutral within a time frame designed to prevent irreparable damage to the environment presents unprecedented challenges. The private sector must deploy financial, material, and engineering resources on a scale never before undertaken — with government providing leadership, removing barriers and supporting industry efforts through policies that mobilize markets to achieve environmental objectives. A key element of supporting private sector initiative to address climate change is policies that help form and sustain markets that supply, finance and generate demand for the technologies necessary to transform our energy infrastructure. The characteristics and examples of these policies are explored in detail. Companies that respond to these challenges both by mitigating greenhouse gases and adapting to climate change will enhance their own competitiveness and contribute to society in the process. Companies that embrace the challenge to decarbonize their manufacturing operations, whether in response to regulation (or the threat of regulation) or market opportunities, invariably discover ways to improve their operations in the process that could potentially enhance their ability to produce better products, more efficiently. The book explores examples of companies that have redesigned their products and manufacturing processes, and in doing so transformed themselves and reshaped their industries. As in the case of companies mitigating greenhouse gas emissions, companies that lead their industries in adapting their own operations to a changing physical environment are more likely to ensure their resilience in a changing business environment. A Difficult Relationship: letters of Edward Thompson and Rabindranath Tagore, 1913-1940/ Uma, Das Gupta (ed.) - Oxford University Press, New Delhi, 2003; 253p.

This book documents the remarkable relationship between Rabindranath Tagore (1861-1941) and Edward J. Thompson (1886-1946) through the letters they exchanged over almost 30 years. Based on a collection of letters, cablegrams and greeting cards, it provides new insights into the personalities of these two eminent individuals living and working in late colonial Bengal. Tagore and Thompson met as poets in 1913 and became friends intantly, but their relationship got strained soon after mainly due to personal failings. Tagore won the Nobel Prize for literature in 1913 and the West feted him as a mystic poet from the East in line with their romantic stereotype about the Orient. Thompson disagreed with the West's representation of Tagore and sought to rectify it by writing two books on Tagore's life and work. He persisted in his criticism of both Tagore's English translations and his image in the West. Tagore was at first irked by these books but later admitted to the weakness of his translations. The letters between Tagore and Thompson are a window to those developments: of their instant intimate friendship, the stressful turn it took, and the reconciliation they reached. At a broader level, the book throws light on contemporary Indo-British cultural and political history. A well-conceived and skilfully written biographical essay, this book will interest scholars of literature, culture, history, and South Asian studies as well as


