	As per circular dated 16/08/2023, the e-Office system was implemented in this office to ensure swift & timely processing of files.
4.	Systematic improvements in record keeping of official vehicles including hired vehicles:
	Log-books are being maintained in accordance with the guidelines issued on the subject from time to time & systematic improvements have been noticed.
5.	Systemic improvements in Tender Register entries:
	All the purchases/tendering are done through GeM Portal & entries are recorded accordingly.
