- 6 Contours of Value Capture: India's Neoliberal Path of Industrial development/ Roy, Satyaki -- Cambridge University Press: New York, 2020; xiv; 202p. 52177

This book provides a critical perspective on contemporary debates on industrialisation in India. It aims to study the process of industrialisation at a conceptual level and articulate and contest the evolving debates and discourses. Instituting market-led growth in India ended in a trajectory that depends heavily on profit-income-led and corporate-driven growth. However, the performances as well as fault lines assessed in terms of industrial growth are often restricted to a discourse on the shifting relative importance of agriculture, industry and services and are largely pegged on the state versus private debate. It appears that the heterogeneous space of critical perspective tends to undermine the more fundamental questions that need to be raised concerning the larger perspective of capitalist industrialization in India. This book addresses these questions and provides insights into the complexities of the process and growth of industrialization as it has played out in contemporary India.

- 7 Corporate finance: theory and practice in emerging economies/ Mahajan, Sunil -- Cambridge university press: New York, 2020; xxvi, 337p. 52178

This book introduces corporate finance to first-year students in business schools. Basic subjects such as marketing, human resources and finance are fundamental to the learning of a business manager. - 8 Demanding Development: The Politics of Public Goods Provision in India's Urban Slums/ Auerbach, Adam Michael. -- Cambridge university press: New Delhi, 2020; xvii, 304p. 52179

The objective of this work is to India's urban slums exhibit dramatic variation in their access to local public goods and services - paved roads, piped water, trash removal, sewers, and streetlights. Why are some vulnerable communities able to demand and secure development from the state while others fail? Drawing on more than two years of fieldwork in the north Indian cities of Bhopal and Jaipur, Demanding Development accounts for the uneven success of India's slum residents in securing local public goods and services. Auerbach's theory centres on the political organization of slum settlements and the informal slum leaders who spearhead resident efforts to make claims on the state - in particular, those slum leaders who are party workers. He finds striking variation in the extent to which networks of party workers have spread across slum settlements. Demanding Development shows how this variation in the density and partisan distribution of party workers across settlements has powerful consequences for the ability of residents to politically mobilize to improve local conditions.

- 9 Democracy And Social Movement A Sociological Analysis of Bihar's Backward Class Movement/ Singh, Shashi Bhushan. -- Ane Books Pvt.Ltd: New Delhi, 2020; viii; 154p. 52180

Why do men rebel? What is the logic of political alliances? How do agents and social structure interact during social movements? By studying intensively Bihar's backward class movement, the book tries to explore and answer some of these questions. Based on first-hand information about the region under study, an attempt has been made to understand the relationship between social structure and social movements. A social movement is a long-drawn process, whereas, in the initial years, a group of people struggle to create a conducive environment (social structure) for the origin of a social movement. Initially, the social structure remains hostile, since erstwhile dominants use harsh measures to crush any voice that may go against their domination. However, some people have the vision, perseverance and charisma to prepare the environment for the origin and growth of the movement. Over time, as the situation becomes favourable, a large number of people become part of the movement leading to a significant change in the social structure. However, further change in social structure makes the situation hostile to the sustenance of the social movement. At this point, the movement starts losing its steam.

- 10 Development of environmental laws in India/ Kohli, Kanchi -- Cambridge: New York, 2021; xiii, 367p. 52181

This book is an attempt at presenting a critical analysis of the close relationship between India's development post-independence and the formulation, enactment

and implementation of environmental laws in the country. It will engage with the deeper implications of these laws - some of which were enacted by the British and the princely states pre-independence - and examine how they have a bearing on the socioeconomic and political ethos of the time. It will also trace recent developments in India's environmental laws and how their implementation impacts the environment and the future of environmental justice in this country. This work will examine the politics behind the enactment of these laws in the garb of protecting the environment. Certain laws which were implemented pre-independence by the British were aimed at making environmental resources a commodity - to expedite the extraction of timber, minerals and other resources. Though the scenario changed post-1970s; in the 42nd amendment to the Constitution in 1976, environmental protection was made a part of the non-justiciable Directive Principles of State Policy - a fundamental duty of every citizen. This move of the government earned many accolades across socio-political sections, but one has to bear in mind the period during which it was implemented - the infamous Emergency regime. The book envisions interpreting the discourse of environmental laws in India along these lines. It will look at the developmental-protectionist nature of the laws and also at the politico-economic factors at play.

- 11 Essential role of Social Science Information System in Library Science/ Kumar, Anil. -- Ess Ess Publications: New Delhi, 2019; xviii, 393p. 52157

This book results from a continued strong belief in the need for a text that focuses on social science information systems in library science issues of the present and future in a distinctive pattern. The increasing interest in the study of society and societal problems by thinkers has created a growing demand for social science courses in colleges. This edition is incorporated with many suggestions from both the social science and library information system side, as it focuses on the critical roles of librarians and teachers. Social Science is a vague subject to be explored and many other books by experts in library science can be used for referral along with this book. This book can facilitate new learners to acquaint with the basic knowledge of social science and library information systems which can be applied in the practical experience of academics and library areas. An effort has been made to explain the concepts simply and comprehensively to develop a foundation for the new library professionals. - 12 From hierarchy to ethnicity: the politics of Caste in twentieth-century India/ Lee, Alexander -- Cambridge University Press: New Delhi, 2020; xiv; 275p 52182

The main focus of this book is Caste identities have been fundamental in shaping Indian politics, loyalties, the structure of the party system, and the distribution of public resources. This book explains when and how caste identities became politicized, and how the nature of caste itself changed over time. How caste is understood is dependent on time and place; some understand it as an integrated system based on subtle gradations of hierarchical difference, while others perceive it as a set of bounded groups similar to ethnicities in other countries across the globe. Using a wide range of historical data sources, the book shows how these identities evolved from the colonial period to the present. It describes how uneven economic development shifted the set of groups and regions where caste is important, while the spread of mass politics and the corresponding decline of patrimonial politics led to a decline in the hierarchical nature of the system. While colonial rule established some of the structural conditions of these changes, the enthusiasm with which caste activists responded to these conditions fluctuated from group to group. Even after these changes, the caste system in India differs from ethnic politics in other parts of the world, in ways that reflect its hierarchical history. The theory discussed in this book foregrounds how identity politics can vary not just between countries, but between groups, and how the modern conception of the ethnic group is the product of a long, and highly contingent, historical process.

- 13 Global environmental challenges and solutions/ Sebastian, John -- Ishwar Books: Delhi, 2021; 232p. 52183

This book deals with the environmental challenges related to pollution and its health effects on human beings. The author endeavours to discuss the various issues in the light of international agreements, policies of world leaders and their countries and the scepticism of developed countries to reduce the carbon footprint.

- 14 Handbook of Hinduism: ancient to contemporary/ Nadkarni, M.V -- Ane Books Pvt.Ltd.: New Delhi, 2019; xv, 348p. 52184

This book explores Hinduism is much misunderstood, by non-Hindus and Hindus alike. Some doubt if it is even a religion. One of the tasks of the book is to clear confusion about this unique religion. The book has two Parts. The first explains in five chapters what Hinduism is and what it is not. Dr Ambedkar had advised that Hinduism be interpreted, not in terms of rules and rituals, but in terms of principles and philosophy. This is what this book does. Apart from elaborating on the theology, metaphysics and spiritual seeking in Hinduism, it presents its moral philosophy rooted in Truth and Non-violence, as Mahatma Gandhi had emphasized. In the process, the book probes into how Hinduism cares for this world, and how far it is socially engaged and environmentally sensitive. It also shows why Hinduism is neither Brahminism nor a caste system. The second part of the book expounds on the dynamics of Hinduism, which combines continuity with change, and how it has emerged as a world religion capable of showing the way to solace and happiness

in these troubled times. Though rooted in the Vedas and Upanishads, Hinduism is not limited by them, including as it does the democratic and spiritual aspirations of the masses which found expression in the Bhakti Movements during the middle age and also modern times. Equality of human beings and respect for differences in faiths and traditions are seen as intrinsic to Hinduism, making it possible for India to survive as a secular democracy with freedom of religion to all and home to a wide variety of faiths and cultures. The book includes anecdotes, shlokas and poems, making it enjoyable and authentic. Though scholarly, it is not tedious.

- 15 Himalayan challenge: India, China and the quest for peace/ Swamy, Subramanian -- Rupa Publications: New Delhi, 2020; xv, 240 p. 52163

This book explores In September 1978, at the invitation of the prestigious Chinese People's Institute of Foreign Affairs, Subramanian Swamy, then a Lok Sabha Member of Parliament of the ruling Janata Party and an elected member of the Party's National Executive travelled to China as an envoy of the then Prime Minister, Morarji Desai, where he met senior leader Ji Pengfei. This led to the first contact, since 1962, between the ruling parties of both countries. Later, in April 1981, Swamy, the then deputy leader of the Opposition, was invited to meet China's Supreme leader, Chairman Deng Xiaoping. In this historic 100-minute meeting, Swamy successfully persuaded Deng to reopen the Kailash Mansarovar route for Hindu pilgrims. In August of that year, he also led the first delegation to the holy site, which he revisited as a guest of the Chinese government in June 2016. It is this vast, first-hand experience that Swamy combines with a provocative exploration of historical sources and fascinating new insights to create the Himalayan Challenge—the most compelling and definitive account of India–China relations. From uncovering the perfidy committed by the British vis-à-vis the McMahon Line in 1936 and the circumstances leading to the folly of war in 1962 to the current fluid situation at the border, this seminal work effortlessly blends meticulous scholarship and memoir-style writing in an intellectually rich fashion. Swamy breaks new ground when he suggests a middle path—grounded in pragmatism, and not carried out over fear or overreaction—that India must take in her interactions with China.

- 16 Hindu-Buddhist Architecture in Southeast Asia/ Singh, Birendra Kumar -- Ishwar Books: New Delhi, 2018; vi, 280p. 52185

This book deals with the technical, artistic and architectural aspects of the Hindu and Buddhist monuments from the beginning until today in Southeast Asia. This book will be useful reading for all those interested to learn about Hindu-Buddhist Heritage art.

- 17 Hindutva and Dalits: perspectives for understanding communal Praxis/ Teltumbde, Anand [ed] -- SAGE Publications India Pvt. Ltd.: New Delhi, 2020; lx, 311p. 52172

The objective of this work is to the teachings of Babasaheb Ambedkar against Hinduism and its pernicious caste system, which he forsook to become a Buddhist, many Dalits have turned to Hindutva. The RSS under Balasaheb Deoras began to

appropriate Ambedkar, engaging with Dalits and Adivasis, Hinduizing their beliefs, providing social welfare and binding them in a political alliance. *Hindutva and Dalits: Perspectives for Understanding Communal Praxis* takes a comprehensive view of the birth and growth of the Hindutva movement and its specific impact on Dalits. Part I, *Theoretical Perspectives*, explores the attitude of Hindutva vis-à-vis Dalits in its various manifestations. Part II, *Hindutva in Operation*, covers empirical evidence of its impact on Dalits. The contributors, distinguished scholar-activists, offer a provocative analysis of why both Dalits and Adivasis are drawn to Hindutva. As analysed by Tanika Sarkar in her incisive Foreword, Hindutva's hegemonic agenda lets 'subalterns develop a stake in their subordination, not in resignation or despair but in eager self-identification with it'. The great strength of this collection is that it asks difficult questions that need to be asked and yet have no easy answers. The book, thus, makes an invaluable contribution to the debate and takes it forward.

- 18 *Housing and politics in urban India: opportunities and contention/ Dhananka, Swetha Rao -- Cambridge university press: New York, 2020; xvi, 232p.* 52186

The main focus of this book is Providing adequate housing in an increasingly urbanized world is a major challenge in current times. *Housing and Politics in Urban India* puts together a compelling story based on a fine-grained analysis of housing processes, as lived by slum-dwellers and their voice-bearers. It situates the lived experience of claiming adequate housing within informal transactions and negotiations of patronage networks vis-à-vis the formal institutional opportunities and closures of Indian democracy. In doing so, it extends an innovative array of conceptual and methodological tools to grasp the context in which housing claims succeed and fail. This book contributes by responding to critical areas of social movement scholarship and by displaying community engagements and tactical strategies to bring about transformative change to claim adequate housing and resist co-opting forces for socially sustainable housing futures. The book attempts to map India's political opportunities and closures for claim-making in general and housing grievances in particular. It offers a comprehensive insight into community processes and the imbricated worlds of formal policy prescription, implementation, and informal practices of negotiation and political loyalties that affect housing provisions for the urban poor.

- 19 *Humanities at the crossroads: reflections on theory, culture and resistance/ Walia, Shelley-- Orient Blackswan Private Limited: New Delhi, 2020; xi, 207 pages.* 52187

This literature scrutinizes Against the backdrop of a neoliberal world in danger of being taken over by totalitarian forces, *Humanities at the Crossroads* calls for a second renaissance in the disciplines of humanities and the liberal arts. The author places on these the responsibility of leading the way towards more progressive politics and social advancement. The author argues that only when academics engage with social critique and resistance can literary and cultural theory emerge as powerful weapons in the battle against hegemony. Arguing that academic scholarship needs to move beyond the confines of university corridors, the author calls upon the modern intellectual to confront totalitarian forces through a commitment to the ideals of liberty, equality and justice. The chapters explore the

philosophies of intellectuals such as Nietzsche, Gramsci, Arendt, Chomsky, Benjamin, and Raymond Williams, highlighting their moral courage and critical scholarship. It also studies dissension, intervention and resistance—which include 'weapons' such as music and art—and which could form a counter-hegemonic strategy of humanitarian politics that could bring society back on a progressive, liberal path.

- 20 In pursuit of Unhappiness/ Jahanbegloo, Ramin. -- Orient Blackswan Private Limited: New Delhi, 2021; 96p. 52188

This literature discusses In today's world, happiness and well-being are often dictated to us by the State or by mass culture and shallow, consumerist and false modes of being. Not to be happy is, by definition, to be marginal, a misfit and a dissenter. In such a world, unhappiness becomes the forbidden universe of those for whom it is an act of dissent against the normative collective experience of conformism, contentment and mediocrity. It also exhorts us to closely examine the meaning of happiness. The pursuit of unhappiness, then, is to confront life in its totality, and presents an alternate horizon of truth, meaning and value for human beings, says renowned philosopher Ramin Jahanbegloo. Life is a beautiful adventure which deserves to be lived for its own sake, fully and well; but a life full of pain without an exit door is a dark and lonely prison. Suicide, rather than being an act of despair or hatred of life, is the ultimate act of human freedom and agency by which individuals have shown that they control their destiny and opposed the tyranny of power, be it of society or the State. This freedom belongs to those who dare to live an examined life and strive to preserve their marginality, integrity and autonomy. In a violent, indifferent world without God and without hope, suicide offers the fragile mortal grappling with meaningless suffering a mode of transcendence and immortality, and freedom from the fear of death, which is, as Montaigne said, the origin of another life.

- 21 India 2030: the rise of a Rajasic nation/ Chikermane, Gautam -- Ebury Press: Gurgaon, 2021; xiv, 290 p. 52164

This book is ten-year time compression. It captures the India of 2030 and hands it to us today. It walks a decade-long journey, with all its major and minor trails, and tells us what India 2030 will look like. This is not a prescriptive book-it does not tell us what to do or how to get there. This is a predicative book-it tells us what will happen. This book delves into the world of ideas. It may look like a pragmatic guide to help citizens negotiate the twenty theme landscapes through the 2020s -and it is.

- 22 Indian philosophies and philosophers/ Gupta, Manoj Kumar. -- Ishwar Books: New Delhi, 2018; vi, 320p. 52189

Indian Philosophy refers to ancient philosophical traditions of the Indian subcontinent. The principal schools as classified as either orthodox or teterodox-astika or nastika- depending on one of three alternate criteria: whether it believes the Vedas are a valid source of knowledge; whether the school believes in the

afterlife and Devas. There are six major schools of orthodox Indian Hindu philosophy Nyayam Vaisheshika, Samkhya, Yoga, Mimansa and Vedanta, and five major heterodox schools-Jain, Bhuddhist, Ajivika, Ajnana and Carvaka. However, there are other methods of classification; Vidyaranya for instance identifies sixteen schools of Indian Philosophy by including those that belong to the Saivaand Rasesvara traditions. This book gives a great overview of philosophy.

- 23 India's Pakistan policy: how think tanks are shaping foreign relations/ Bhatnagar, Stuti-- Routledge: New York, 2021; 167 p. 52165

This book critically examines the role of think tanks as foreign policy actors. It looks at the origins and development of foreign policy think tanks in India and their changing relevance and position as agents within the policy-making process. The book uses a comparative framework and explores the research discourse of prominent Indian think tanks, particularly on the India-Pakistan dispute and offers unique insights and perspectives on their research design and methodology. It draws attention to the policy discourse of think tanks during the Composite Dialogue peace process between India and Pakistan and the subsequent support from the government which further expanded their role. One of the first books to offer empirical analyses into the role of these bodies in India, this book highlights the relevance of and the crucial role that these institutions have played as non-state policy actors. Insightful and topical, this book will be of interest to researchers focused on international relations, foreign policy analysis and South Asian politics. It would also be a good resource for students interested in a theoretical understanding of foreign policy institutions in general and Indian foreign policy in particular.

- 24 India's tribes: unfolding realities/ Srivastava, Vinay Kumar; Mohanty, Manoranjan [ed.] -- SAGE Publications India Pvt. Ltd: New Delhi, 2021; lviii, 294p. 52173

India's Tribes: Unfolding Realities brings together critical essays on tribal communities, some of the most marginalized people in India. The chapters, authored by eminent scholars who made significant contributions to the field of Tribal Studies, present important research on resource appropriation, poverty, education, health, economy and the tribal situation. They discuss issues such as problems of development-induced displacement, labour exploitation, sustainable livelihoods, politics of religious conversion, tribal women's issues, resistance movements and policy responses. The editor's introductions reflect on the predicaments of tribal people in contemporary times, besides presenting a comprehensive perspective on the contribution of the selected essays to an understanding of tribal life. The series 'Social Change in Contemporary India' brings together key texts published in the prestigious journal Social Change, from 1971 till the present time. These writings, most of which are considered canonical, address important issues in health, education, poverty and agriculture, with a special focus on disadvantaged groups. The essays will help readers identify key points in the history of policymaking in India and major discourses and debates and their impact.

Now the world is experiencing a second Golden Age of Classification and Indexing in the World Wide Web. The faceted classification was prophesized as the basis of all knowledge organization systems and tools in the mid-1950s. This prediction is proving true today. Classification has bounced back with a vengeance. The late Eugene Garfield aptly said, "Ranganathan is to library science what Einstein is to physics." This work presents a summary and the importance of Ranganathan's work in classification. He left a huge body of thought-provoking classification literature with multidimensional applications. Apart from the Classification Research Group (CRG) disciples, his work has inspired many in the LIS profession. Apart from a summary and chronology of his classification work, this book portrays the current scene on classification studies, practices, and literature in India. It makes a hearty plea to know, value, preserve, and perpetuate his legacy, which has brought glory to the Indian LIS profession. This book is a reminder of his greatness, relevance and our enduring debt to him.

Governments increasingly depend upon statistics for planning and evaluation of interventions as well as self-representation. Numbers in India's Periphery examines systematic and deliberate errors in government statistics. Using field interviews, archival sources and secondary data, the book explores the shifting relations between various kinds of statistics and charts their cradle-to-grave political career in Nagaland, a state located in India's landlocked ethnographic periphery stretching from Mizoram to Jammu and Kashmir. This book examines the area (1951-2018), population (1951-2011) and National Sample Survey statistics (1973-2014) of Nagaland, treating them as part of a larger family of mutually constitutive statistics embedded in a shared context. It shows that Nagaland's government statistics suffer from sustained and large errors. It argues that statistics are shaped by a combination of factors, including contests over the

delimitation of administrative units and electoral constituencies in the context of weak institutions and dominance of the state in the economy. It also engages with the shared experience of other states of India, including Assam, Jammu and Kashmir and Manipur, and other countries in Africa and Asia and non-governmental statistics such as church membership data. Numbers in India's Periphery uncovers a mutually constitutive relationship between data, development and democracy deficits and offers an exciting account of how statistics are social artefacts dynamically shaped over their life cycle by political and economic factors. It contributes to the under-researched field of the political economy of statistics in developing countries
