1	Aging in the Family/ Dickinson, George E.   Sanders, Brenda S.-- Routledge taylor & francis group London: New York, 2019; xiv,198p.	51381

This book describes that with a rapidly aging population throughout the world, the issue of larger percentages of older adults has repercussions for both policy and the job market. Whether a university student about to seek a full-time job or a caregiver for an older person, Aging in the Family should enhance the reader's knowledge and skills. The main topics covered in this volume include marital status of older adults, support systems within families, crises with older adults within families, the resilience of older adults entering the latter stages of life, practical information involving caregiving, aging in place, and various social services for an aging population. The reader will be made aware of intergenerational interactions between older adults and other family members in various cultures. The role of ethnicity and socio-economic status in health issues of older adults will be discussed, as will the application of technology to an aging population. Though problems certainly exist as one ages, the overall thrust of the book is toward the positive aspects of growing old. Numerous theories exist to probe research and understanding of older adults in families. The relation between theory and research will be helpful to many students of aging in the family. Older adults are generally married, yet cohabitation and other options are alive and well too. Ageism, death, and abuse, unfortunately, are issues affecting aging. Yet, most older adults in the US and Western Europe report living independently and being satisfied with their lives. Aging in the Family will be an interesting read for anyone wanting to learn about older adults and family relationships, as it exhibits a blend of both theoretical and practical matters.

This book describes that the Art and Science of Making Up Your Mind presents basic decision-making principles and tools to help the reader respond efficiently and wisely to everyday dilemmas. Although most decisions are made informally (whether intuitively without deliberate thought, or based on careful reflection), over the centuries people have tried to develop systematic, scientific and structured ways in which to make decisions. Using qualitative counterparts to quantitative models, Rex Brown takes the reader through the basics, like 'what is a decision' and then considers a wide variety of real-life decisions, explaining how the best judgments can be made using logical principles. Combining multiple evaluations of the same judgment ("hybrid judgment") and exploring innovative analytical concepts (such as "ideal judgment"), this book explores and analyzes the skills needed to master the

basics of non-mathematical decision making, and what should be done, using real world illustrations of decision methods. The book is an ideal companion for students of Thinking, Reasoning and Decision-Making, and also for anyone wanting to understand how to make better judgments in their everyday lives.

- 3 Bourdieu and After: a guide to relational phenomenology/ Atkinson, Will-- 51382  
Routledge Taylor & Francis Group: New York, 2020; xi,290p.

This book tells that Pierre Bourdieu was the most influential sociologist of the late 20th century. The framework, he developed continues to inspire countless researchers across the globe and provokes intense debates long after his death. Novel concepts, innovative applications and countless elaborations spring up every day, bulking out and shaping a distinct, if not always entirely consistent, body of work that might be characterised as a recognisable tradition. For those coming to Bourdieu for the first time, therefore, and interested in using his ideas in their own research, it no longer makes sense to confine oneself to the ideas of the man himself. An overview of the varied ways his concepts and arguments have been deepened and updated to make sense of new times or to fill certain gaps, and how insights on seemingly disconnected topics weave together into a bigger picture, is not just desirable but essential. Bourdieu and After aims to provide exactly this overview. Working closely with Bourdieu's own writings, but also covering a wide range of research and literature inspired by him, it aims to guide the reader through the key principles, the major and minor concepts and the concrete findings of Bourdieusian sociology as clearly and comprehensively as possible. It explains the difficult and often overlooked philosophical foundations, walks through the logic of famous terms like 'field', 'habitus' and 'capital' and demonstrates how they have been or can be used to provide powerful accounts of colonialism, the emergence of nation states and the rise of global social relations. It covers topics that Bourdieu was famous for analysing, like class and educational inequality, yet also traverses subjects on which he said little but that others influenced by him have tackled in depth, such as ethnicity, sexuality and family. Along the way Atkinson seeks to undermine some of the common criticisms levelled at Bourdieu while identifying remaining gaps and limitations. Rather than simply recognising the problems, however, Atkinson proposes possible solutions too – solutions that are facilitated, he argues, by characterising Bourdieusian sociology as what he calls 'relational phenomenology'.

- 4 Capitalism and Critique: Unruly Democracy and Solidarity Economics/ Martin, 51383  
J. Edward | Torres, D. Rodolfo | Pimentel, S. Mateo-- Routledge Taylor &  
Francis Group: New York, 2019; xi,111p.

This book tells that while there are signs of recovery from recent economic collapses, relatively few protective measures are in place in the United States

to prevent future crises and widespread destruction of livelihoods around the globe. This book, a follow-up and further development of Martin's and Torres' ideas in their acclaimed *Savage State: Welfare Capitalism and Inequality*, contains a synthesis and critique of economic theory with historical case studies and new discourse on American globalism and its failures to provide for the economic security of millions of people. Since the original publication over ten years ago, there has been a resurgence in radical political economy and critical theory. Instead of "demonizing" the market, *Capitalism and Critique* draws lessons from the new directions in social theory and seeks clear solutions for future modes of capitalism

- 5 Christianity and Sociological Theory: Reclaiming the Promise/ Scimecca, Joseph A.-- Routledge Taylor & Francis: New York, 2019; 236p. 51384

This book offers a history of sociological theory from a Christian perspective, tracing the origins of sociology from the beginnings of Western science as introduced by the Scholastics of the twelfth century, which, when combined with their emphasis on rationality, led to the Enlightenment "science of man"--an emphasis that eventually resulted in sociology, which combined empiricism and a Christian moral philosophy. With chapters focusing on the Scholastics, the Enlightenment, the rise of sociology in France, Germany, and the United States, and the legacy of Positivism, *Christianity and Sociological Theory* shows how the emphasis on moral philosophy was eventually lost as sociology rejected Christian underpinnings, resulting in what can only be described as an extremely limited sociology. A rigorous exploration of the trajectory of the discipline from its Christian origins, this volume reveals the potential that exists for sociology in an era of postmodern thought to reclaim its promise through a re-introduction of Christianity.

- 6 Civilization at the Crossroads: Social and Human Implications of the Scientific and Technological Revolution/ Richta, Radovan-- Routledge Taylor & Francis Group: New York, 2018; 372p. 51385

The book describes that the dynamic advance of scientific discovery in recent decades, together with the rapid development of the material base of human life, is assuming the magnitude of revolutionary changes that promise in the long run to transform the nature of civilization and open up boundless prospects for a new form of society. These considerations underscore the urgency of probing the substance of the scientific and technological revolution of our day — its social and human roots and implications. In 1965, a systematic examination of these problems was undertaken in Czechoslovakia by a research team made up of workers in various branches of science. The group was attached to the Institute of Philosophy, Czechoslovak Academy of Sciences, and headed by Dr. R. Richta, who has been working in this field for some time. The original purpose was to make a brief report on urgent

ideological and theoretical matters arising from the new advances in science and technology. However, a fuller analysis led to a more ambitious and long-term project. Its aim was to draw, insofar as this was possible, a synthetic picture of the scientific and technological revolution against the background of the two social systems — socialism and capitalism — while also attempting to suggest ways of handling the inevitable social and human issues involved

- 7 Critical Thoery and Social Transformation: Crisis of the Present and Future Possibilities/ Delanty, Gerard-- Routledge Taylor & Francis Group: New York, 2020; vi,251p. 51386

This book accounts that Critical Theory and Social Transformation provides an exploration of the major themes in critical social theory of recent years. Delanty argues that a critical theory perspective can offer much-needed insights into the pressing socio-political challenges of our time. In this volume, he advances the need to reconnect social theory and social research and to return to the foundational concerns of critical social theory. Delanty engages with the key topics facing critical social theorists: capitalism, cosmopolitanism, modernity, the Anthropocene, and legacies of history. The connecting thread is that the topics are all contemporary challenges for critical theory and relate to major social transformations. The notions of critique, crisis, and social transformation are central to the book. Critical Theory and Social Transformation will be of interest to the broad readership in social and political theory. It will appeal to those working in sociology, political sociology, politics, and international studies and to anyone with an interest in any of the chapter-specific topics, such as public space, memory, and neo-authoritarianism.

- 8 Doing Excellent Social Research with Documents: Practical Examples and Guidance for Qualitative Researches/ Grant, Aimee-- Routledge taylor & francis group: New York, 2019; xxiv,190p. 51387

This book accounts that in today's society, we increasingly create and consume written content and images. This includes a range of sources, from social media posts to records held within organisations, and everything in between, including news articles, blogs, shopping lists and official government documents. Critically reading these 'documents' can help us to understand a huge amount about society. Doing Excellent Social Research with Documents includes guidance on how to 'read between the lines', and provides an overview of six research projects which use documents as data.

- 9 Doing Research In And On The Digital: Research Methods Across Fields Of Enquiry/ Costa, Cristina and Condie, Jenn (Ed.)-- Routledge Taylor & Francis Group: New York, 2019; xii,214p. 51388

This book describes that as a social space, the web provides researchers both with a tool and an environment to explore the intricacies of everyday life. As a

site of mediated interactions and interrelationships, the 'digital' has evolved from being a space of information to a space of creation, thus providing new opportunities regarding how, where and, why to conduct social research. *Doing Research In and On the Digital* aims to deliver on two fronts: first, by detailing how researchers are devising and applying innovative research methods for and within the digital sphere, and, secondly, by discussing the ethical challenges and issues implied and encountered in such approaches. In two core Parts, this collection explores: content collection: methods for harvesting digital data engaging research informants: digital participatory methods and data stories . With contributions from a diverse range of fields such as anthropology, sociology, education, healthcare and psychology, this volume will particularly appeal to post-graduate students and early career researchers who are navigating through new terrain in their digital-mediated research endeavors.

- 10 Empiricism and the Metatheory of the Social Sciences/ Bhaskar, Roy-- 51389  
Routledge taylor & francis group: New York, 2018; xxii,272p.

This book tells that a picture has indeed held modern Western philosophy captive, that of the universe as a vast machine whose iron laws are best understood as exception less empirical regularities which, as it were, determine the future before it happens. This fantastic conception commands the assent, not just of positivistically-minded naturalists but of all the great anti-naturalists who champion a very different view of human action as a domain of freedom 'that somehow cheats science'. The most fundamental move in Roy Bhaskar's system of philosophy, the germ of everything that followed, was to reconceptualise the natural world in transcendental realist terms, 'turning Kant around using his own method'. On this account, the universe is characterized by deep structures, mechanisms and fields that generate the flux of phenomena, and is in open, creative and emergent process. This completely recasts the terms of the debate between naturalism and anti-naturalism by remedying its false grounds and shows how philosophy can be liberated from its anthropocentric/anthropomorphic prison and rendered consistent with the best insights of modern natural science. There is necessity in nature quite independent of humans, but in an open world causation is multiple and conjunctural, the actual course of the unfolding of being is highly contingent and the bases of human freedom can be understood scientifically. Written as a DPhil thesis when Bhaskar was in his mid-twenties, *Empiricism and the Metatheory of the Social Sciences* brilliantly launches this reconceptualization and explores its implications for social science in the course of carrying through the metatheoretical destruction of empiricism. It will be indispensable reading for anyone interested in the development of Bhaskar's thought, in transcendental realism, and in the critique of empiricism, more generally of the philosophical discourse of Western modernity.



- 11 Experiencing Multiple Realities: Alfred Schutz's Sociology of the Finite Provinces of Meaning/ Benta, Marius Ion-- Routledge taylor & francis group: New York, 2018; xii,151p. 51390

This book offers a theoretical investigation into the general problem of reality as a multiplicity of 'finite provinces of meaning', as developed in the work of Alfred Schutz. A critical introduction to Schutz's sociology of multiple realities as well as a sympathetic re-reading and reconstruction of his project, Experiencing Multiple Realities traces the genesis and implications of this concept in Schutz's writings before presenting an analysis of various ways in which it can shed light on major sociological problems, such as social action, social time, social space, identity, or narrativity.

- 12 Exploring Social Inequality In The 21st Century: New Approaches,New Tools,and Policy Opportunities/ Jarman, Jennifer and Lambert, Paul(Ed.)-- Routledge Taylor & Francis Group: New York, 2019; xv,184p. 51391

This book provides up-to-date and thorough analysis from the perspective of a group of researchers at the forefront of social stratification analysis. Exploring Social Inequality in the 21st Century is a clear and critical overview of current debates about social inequality. It includes new information, tools, and approaches to conceptualising and measuring social stratification and social class, as well as informative case studies. Throughout, the researchers describe the direct and indirect costs of social inequality. Divided into two parts - Conceptualising and Measuring Inequality; and Costs and Consequences of Inequality in the areas of Education, Employment, and Global Wealth - it includes new findings about the growth of wealth inequality in the G20 countries, and a detailed examination of tax policies designed to reduce inequality without affecting economic growth. With substantial contributions to the analysis of inequalities in education, and explanations of the processes and consequences of social and gender-based exclusion, this book is essential reading for anyone interested in understanding contemporary social inequality. This book was originally published as a special issue of the journal Contemporary Social Science.

- 13 Future Courses of Human Societies: Critical Reflections From the Natural and Social Sciences/ Ghimre, Kleber(Ed.)-- Routledge Taylor & Francis Group: New York, 2018; xvii,202p. 51392

This book accounts that the future as a field of inquiry, debate or forecasts continues to flourish. However, this book differs from existing literature in several important ways. It is not another publication on future scenarios guided by a linear technological fix - nor is it simply a volume of new statistics on economic, demographic or geopolitical developments. Rather, Future Courses of Human Societies explores and builds a general framework for the long-term evolution of human societies. Drawing upon a wide range of insights from

across the social and natural sciences, the authors of this title present original, exploratory methodological and analytical approaches to examining the future. Encouraging the reader to deepen their knowledge and encourage critical thinking, three themes are considered in their complexity and multi-dimensionality: technological innovations; future 'progress'; and the critical aspect of organizing collective life in the future. Furthermore, in contrast to previous studies which have embraced a relatively short time-span, this text incorporates perspectives from the immediate to the distant future, extending to several centuries and even millennia. An interdisciplinary and internationally comprehensive volume, *Future Courses of Human Societies* is a key source for students and researchers interested in fields such as future studies, technology in society, interdisciplinary learnings on social and natural sciences and future economic and political evolutions.

- 14 Gender , Branding, and the Modern Music Industry: The Social Construction of Female Popular Music Stars/ Lieb, Kristin J.-- Routledge Taylor & Francis Group: New York, 2018; xxvii,265p. 51393

This book provides a rare lens on the rigid packaging process that transforms female artists of various genres into female pop stars. Stars-and the industry power brokers who make their fortunes-have learned to prioritize sexual attractiveness over talent as they fight a crowded field for movie deals, magazine covers, and fashion lines, let alone record deals. This focus on the female pop star's body as her core asset has resigned many women to being "short term brands," positioned to earn as much money as possible before burning out or aging ungracefully. This book, which includes interview data from music industry insiders, explores the sociological forces that drive women into these tired representations, and the ramifications for the greater social world.

- 15 Gender, Work and Migration: Agency in Genderd Labour Settings/ Amrith, Megha and Saharaoui, Nina (Ed.)-- Routledge Taylor & Francis Group: New York, 2018; xiv,206p. 51394

This book tells that while the feminisation of transnational migrant labour is now a firmly ingrained feature of the contemporary global economy, the specific experiences and understandings of labor in a range of gendered sectors of global and regional labour markets still require comparative and ethnographic attention. This book adopts a particular focus on migrants employed in sectors of the economy that are typically regarded as marginal or precarious - domestic work and care work in private homes and institutional settings, cleaning work in hospitals, call centre labour, informal trade - with the goal of understanding the aspirations and mobilities of migrants and their families across generations in relation to questions of gender and labour. Bringing together rich, fieldwork-based case studies on the experiences of

migrants from the Philippines, Bolivia, Ecuador, Zimbabwe, Mozambique, Mauritius, Brazil and India, among others, who live and work in countries within Europe, Asia, the Middle East and South America, Gender, Work and Migration goes beyond a unique focus on migration to explore the implications of gendered labour patterns for migrants' empowerment and experiences of social mobility and immobility, their transnational involvement, and wider familial and social relationships.

- 16 Higher Education and Social Inequalities: University Admissions, Experiences, and Outcomes/ Waller, Richard; Ingram, Nicola and Ward Michael, R.M.(Ed.)- 51395  
- Routledge Taylor & Francis Group: New York, 2018; 248p.

This book describes that a university education has long been seen as the gateway to upward social mobility for individuals from lower socio-economic backgrounds, and as a way of reproducing social advantage for the better off. With the number of young people from the very highest socio-economic groups entering university in the UK having effectively been at saturation point for several decades, the expansion witnessed in participation rates over the last few decades has largely been achieved by a modest broadening of the base of the undergraduate population in terms of both social class and ethnic diversity. However, a growing body of evidence exists in the continuation of unequal graduate outcomes. This can be seen in terms of employment trajectories in the UK. The issue of just who enjoys access to which university, and the experiences and outcomes of graduates from different institutions remain central to questions of social justice, notably higher education's contribution to social mobility and to the reproduction of social inequality. This collection of contemporary original writings explores these issues in a range of specific contexts, and through employing a range of theoretical and methodological approaches. The relationship between higher education and social mobility has probably never been under closer scrutiny. This volume will appeal to academics, policy makers, and commentators alike. Higher Education and Social Inequalities is an important contribution to the public and academic debate.

- 17 Human Trafficking: Interdisciplinary Perspective/ Burke, Mary C.(Ed.)-- 51396

This book provide a view of from different disciplines and professions, this text comprehensively explains human trafficking as it exists and is being addressed in the twenty-first century. The first section gives an overview of the issue and contextualizes it within a human rights and historical framework. The second section provides the reader with more detailed, interdisciplinary information about trafficking. The third section, which contains a chapter written by a former FBI agent, focuses on the anti-trafficking movement and addresses international responses to the problem, as well as considerations

for working with victims. Human Trafficking closes with a chapter about how trafficking is being addressed and how individuals, larger social groups, and organizations can get involved in putting an end to the crime and to helping survivors. Human Trafficking is essential reading for professionals in law enforcement, human services, and health care, and for concerned citizens interested in human rights and making a difference in their communities. This book is also intended for use in undergraduate and graduate interdisciplinary courses in human trafficking.

- 18 Nation Apart: The African-American experience and white nationalism/ Birenbaum, Arnold-- Routledge Taylor & Francis Group: New York, 2019; ix,198p. 51380

This book examines the ongoing struggle for social justice by and for African Americans. Examining the persistent rolling back of civil and voting rights for this population and other minorities since the end of Reconstruction, the author discusses the continued colonization of African Americans and the rise of white nationalism before considering what can be done to create a democratic version of Americanism. With discussions on the possibilities that exist for eliminating health disparities, increasing income and reducing wealth inequality, enhancing the urban environment and housing stability, reforming criminal justice, and reconsidering the case for reparations for the descendants of slaves, the author considers whether white nationalism is a threat to Democratic Americanism and if the declining fortunes of working class Americans can be reversed by means of a "Marshall Plan" for the United States. A study of the sustained racial injustices of American society over the last century and a half and their possible remedies, A Nation Apart will appeal to all those with interests in race and ethnicity and questions of social justice.

- 19 Problems with Teamwork, And How to solve them/ Lantz, Annika; Friedrich, Peter and Ulber, Daniela-- Routledge Taylor & Francis Group: New York, 2020; 310,pp 51373

This book offers practical, evidence-based solutions to help professionals implement and support effective teamwork. Lantz, Ulber and Friedrich draw on their considerable professional experience to present common problems in team-based organizations, what empirical research tells us the causes are and which solutions are more effective in overcoming team-based obstacles. In The Problems with Teamwork, and How to Solve Them, nine common problems are identified, ranging from lack of leadership and adaptability to conflict and cohesiveness, accompanied by clear instructions on how to approach and resolve the individual issues. Detailed case studies are presented throughout the book, demonstrating how theory can be applied to real-life situations to produce optimal results for both the team and the larger organisation. By combining theory and practice, and using state-of-the-art

research, the book constructs a cognitive map for identifying problem causes and effect, and step-by-step instructions on how to solve problems. This is essential reading for anyone working in team-based organizations, as well as students and academics in related areas such as organizational psychology and organizational behaviour.

- 20 Social Psychology of Ethnic Identity/ Verkuyten, M.-- Routledge Taylor & Francis Group: New York, London2018; 348p. 51374

This book accounts that in contrast to other disciplines, social psychology has been slow in responding to the questions posed by the issue of ethnicity. The Social Psychology of Ethnic Identity demonstrates the important contribution that psychology can make. The central aim of this book is to show, on the one hand, that social psychology can be used to develop a better understanding of ethnicity and, on the other hand, that increased attention to ethnicity can benefit social psychology, filling in theoretical and empirical gaps. Based on recent research, The Social Psychology of Ethnic Identity brings an original approach to subjects such as: \* ethnic minority identity: place, space and time \* hyphenated identities and hybridity \* self-descriptions and the ethnic self. The combination of diverse approaches to this burgeoning field will be of interest to social psychologists as well as those interested in issues of identity, ethnicity and migration.

- 21 Social Psychology of Living well/ Forgas, Josephg P (Ed.)-- Routledge Taylor & Francis Group: New York, 2018; 362p. 51375

This book surveys groundbreaking work by leading international researchers, demonstrating that social psychology is the core discipline for understanding well-being and the search for meaning. Basic conceptual and theoretical principles are discussed, drawing on philosophy, evolutionary theory and psychology, followed by a review of the role of purposeful, motivated activity and self-control in achieving life satisfaction. The role of emotional and cognitive processes and the influence of social, interpersonal and cultural factors in promoting a happy and meaningful life are discussed. The book will be of interest to students, practitioners and researchers in the behavioral and social sciences, as well as to laypersons for whom improving the quality of human life and understanding the principles of well-being are of interest.

- 22 Thinking Critically about Research: A step-by-step Approach/ Jane Ogden-- Routledge Taylor & Francis Group: New York, 2019; 176p. 51376

This book accounts that we live in an age of unprecedented access to information. The last decade has seen an exponential growth in data and material available, often at the touch of a button. However, this has also made it harder to discern between fact and fiction. What is real and what is fake? What should we believe and what should we reject? In an environment of

information overload, a distrust of experts, the circulation of misinformation and false facts, and public debates based upon poor evidence, *Thinking Critically About Research* comes at a vital juncture. The book is designed to help readers develop a critical understanding of evidence and the ways in which evidence is presented, and to challenge the information they receive in both academic and non-academic sources. The author presents a step-by-step approach with a focus on knowing methods, culminating in a bespoke 'critical tool kit' which offers a practical checklist designed to be used when carrying out research. Also containing learning features including tasks and worked examples, drawing on real research studies, this is an essential resource for students and researchers, and those putting research into practice, who want to have better critical thinking skills.

- 23 *Transitions Between Consciousness and Unconsciousness/ Hesselmann, Guido ed.-- Routledge Taylor & Francis Group: New York, 2019; x,172p.* 51377

This book describes that the empirical study of consciousness is in constant progress. New ideas and approaches arise, methods are being debated and refined, and experimental research over the last two decades has produced a rich body of data, acquired in the aim to better understand consciousness and its neural underpinnings. This volume synthesises this data, focusing on how to understand the relations and transitions between consciousness and unconsciousness alongside exploring and distinguishing conscious experience of sensory stimuli and unconscious states.
