The volume brings together historians, political analysts and political economists to emphasize the interconnectedness of the oceanic space through a detailed analysis of the Bay of Bengal as a space of strategic

and economic significance, particularly for India, but also as a space for re-imagining a new regional community.

- 8** The Indo-Pakistani War of 1971 : indian military intervention in east pakistan / Rikhye, **53228**

According to this book, In 1947, the hurried partition of India and Pakistan by Britain left unresolved the issue of Kashmir, triggering multiple wars between the two nations. The conflict continued with significant wars in 1947-48, 1965, 1971, and 1999, along with ongoing insurgencies since 1987. In 1970, East Pakistan's quest for independence led to a brutal counterinsurgency, followed by India's invasion in 1971. This culminated in a decisive victory for India and the creation of Bangladesh. Ravi Rikhye's detailed account, utilizing official records, personal recollections, rare photographs, and color profiles, narrates the largest military conflict between India and Pakistan, highlighting its profound historical impact.

On the other, the identification of molecular life's constant biological dynamics supports and makes possible the development and stockpiling of effective medical countermeasures. This study is one of the few to take seriously the conceptual implications that the detailed empirical workings of biotechnology have on security practices today. This book will be of much interest to students of security studies, bio-politics, life sciences, global governance, and International Relations in general
