The dictionary tells that arranged alphabetically according to romanized Sanskrit alphabet which takes some getting used to if you're still learning that. A Practical Sanskrit Dictionary is an authoritative resource for learners and scholars alike. Each entry includes a transliteration for easier understanding, etymological information on the root and derivatives, and an indication of the rarity of the word and the literary period to which it belongs.

Agrarian distress and farmer suicides in North India / Singh, Lakhwinder. --52111 Routledge: New York, 2020; xvi, 219p.

This volume provides a comprehensive and detailed socio-economic overview of agrarian distress in India which has manifested in the suicides of farmers and agricultural labourers. Using empirical research and field data from rural India, especially Punjab, this book examines the underlying causes of farmer suicide and steps which can mitigate the crisis. Covering nearly 1,400 rural households, the research in this volume identifies the various dimensions of the deepening crisis in agriculture and farming. It categorises the factors of the problem across different regions and estimates its extent and magnitude. In this updated edition the authors focus on instances of political mobilization and collective movements by farmers struggling to bring the issue of agrarian distress to attention. The book also discusses the implementation of state-waivered loans and compensations and their effect on the farming community. Topical, comprehensive and rich in data, this book will be valuable to scholars and researchers of political economy, agricultural economics, South Asian politics, political sociology and public policy.

3 Agriculture innovation systems in Asia: towards inclusive rural development / Singh, 52112 Lakhwinder and Anita Gill (ed.) -- Routledge: New York, 2020; xxiv, 339p.

This book looks at agricultural systems and rural economies in Asia through the prism of alternative innovation systems, alternative public policy and institutional changes. The massive shifts within the agricultural economy in Asia, geared towards increasing production, has had a direct effect on the livelihood of a large mass of people in rural societies, causing financial and social distress. This book explores a wide range of solutions, such as the role of education, improving technical skills and human capital, along with interactive learning in R&D, harnessing ICTs and institutional innovations, to see how these problems can be alleviated. The volume looks at how these methods can help formulate alternative ways to build sustainable and inclusive agricultural societies, ensure food security, sustainable growth and agricultural productivity. This book, rich in theoretical and empirical matter, will be useful for academics and researchers interested in agricultural innovation, development studies and agricultural economics. It will also be of interest to policymakers and think tanks working towards inclusive social development and sustainability in Asia and the Indian subcontinent.

Because India comes first: reflections on nationalism, identity and culture / Madhav, Ram-- Westland Publications Private Limited:: Chennai, 2020; xii, 285 p.

For the last few decades, Ram Madhav—formerly the national general secretary of the Bharatiya Janata Party—has been observing and participating in Indian politics. Drawing from his years of involvement in politics, Madhav's essays discuss a range of issues that are at the heart of contemporary debates in India: democracy as the responsibility of the head of state, rule of law, peace and public order, Mahatma Gandhi and Gandhi-ism, Ambedkar's ideals, empowerment of women, Indian judiciary, the Ram Janmabhoomi case, abrogation of Article 370, the legacies of Atal Bihari Vajpayee and Arun Jaitley, and Prime Minister Narendra Modi's learnings in governance. Because India Comes First also delves into the decisions made by the BJP-led government over the last few years, diplomatic relationships with India's neighbours and the confrontations with China. Madhav enquires into Indian policymaking and asserts that, going ahead, it must put India first. He calls out liberal fascism, deconstructs our understanding of terrorism in India, argues that opposition to the Citizenship (Amendment) Act is intellectually dishonest, explores how learnings from Black Lives Matter can be applied in the Indian sphere and explains why protests should be rooted in Martin Luther King Jr.'s non-violent approach and not anarchy. The essays in this volume weave a broad tapestry of India's growth into a soft power, and predicts how it will shape up over the next few decades. A must read for those who believe in the new idea of India, and for those who accept that there are two sides to every debate.

Becoming feminist: narratives and memories Guest / Carly-- Macmillan Publishers 7 Ltd: London, 2016; xi, 240 p.

In doing so, it develops a growing body of work concerned with the relationships women forge to feminism's pasts, presents and futures, with a distinct focus on the stories feminist women tell about their lives. Being and meaning: reality and language in Bhartrhari and Heidegger / Alackapally, Sebastian-- Motilal Banarsidass Publishers: Delhi, 2002; xviii, 297 p.

This book is a comparative study of the concepts of Being and Language in Bhartrhari and Martin Heidegger, emphasising the universality of their thinking. Language in Bhartrhari's vision is the medium of the self-expression for the Ultimate Reality (Sabdatattva). In Heidegger's thinking language is the Original Utterance (Sage) which Being speaks to man. Being expresses itself in language, and phenomena in the world occur simultaneously with the occurrence of language. Bhartrhari and Heidegger lead one to the belonging togetherness of Being and being beyond all conceptualizing, transcending the bounds of Orient and Occident.

Breaking through: a memoir / Ahluwalia, Isher Judge-- Rupa Publications India Pvt. Ltd.: New Delhi, 2020; x, 173p.

This is the life story of Isher Judge Ahluwalia, one of the leading Indian policy economists of her generation. Born into a family with eleven children and limited means, where she was one of the first to attend university, she takes us through her journey to Presidency College, Delhi School of Economics and Massachusetts Institute of Technology. She chronicles her career as a young policy economist fighting against the Indian economic orthodoxy that underpinned the license-permitquota Raj, as an institution builder leading the Indian Council for Research on International Economic Relations (ICRIER), one of India's leading economic think tanks for over a decade, and also her most recent role in focusing attention on the challenges of urbanization in India. Narrated with candor and from the heart, this is also a story of a woman balancing career and family, and trying to stay close to her roots as her life path takes her through the power corridors of New Delhi, both through her own career, and through a 50-year-marriage to Montek Singh Ahluwalia. An outsider to Delhi, who ultimately became the consummate insider,

Breaking Through is an account of a remarkable life that was witness to remarkable times.

10 Buddhism and Ecology / Edelglass, William (ed.) -- Motilal Banarsidass Publishers: 52140 Delhi, 2017; xiv, 114p.

Buddhism exists in many different forms in many different countries. In this book Buddhists from Japan, Thailand, Sri Lanka, Vietnam, Tibet and the West offer their approaches to ecology and tell of practical activities as well as Buddhist teachings and philosophy. Stories, pictures and poems add to the picture of Buddhism and ecology and the book concludes with a message from the Dalai Lama. The book provides: new ideas and ways of thinking for Buddhists and non-Buddhists alike; a resource for group discussions and study in colleges and schools.

11 Buddhism and Science /Jason Slone -- Motilal Banarsidass: Delhi, 2015; xii, 163p. 52141

This titles advocates the scientific method and pursues that to a finality that may be called Rationalistic. Buddhism is a combination of both speculative and scientific philosophy. Buddhism is an Asian religion that is based on teachings attributed to Siddhartha Gautama, an upper-class male born in north eastern India in the fifth or sixth century BCE. Gautama became the "Buddha" ("awakened one"), according to tradition, upon achieving "enlightenment" as a result of engaging in a series of spiritual practices, most notably meditation. After achieving enlightenment, the Buddha is said to have gained a perfect understanding of the nature of the world and of human existence, and he spent the remainder of his life traveling and teaching as an itinerant mendicant. The religion of Buddhism is based largely on the teachings attributed to Gautama-Buddh.

12 Capital and ideology / Piketty, Thomas, -- Belknap Harvard: Cambridge, 2020; ix, 52130 1093 p.

The epic successor to one of the most important books of the century: at once a retelling of global history, a scathing critique of contemporary politics, and a bold proposal for a new and fairer economic system. Thomas Piketty's bestselling Capital in the Twenty-First Century galvanized global debate about inequality. In this audacious follow-up, Piketty challenges us to revolutionize how we think about politics, ideology, and history. He exposes the ideas that have sustained inequality for the past millennium, reveals why the shallow politics of right and left are failing us today, and outlines the structure of a fairer economic system. Our economy, Piketty observes, is not a natural fact. Markets, profits, and capital are all historical constructs that depend on choices. Piketty explores the material and ideological interactions of conflicting social groups that have given us slavery, serfdom, colonialism, communism, and hyper capitalism, shaping the lives of billions. He concludes that the great driver of human progress over the centuries has been the struggle for equality and education and not, as often argued, the assertion of property rights or the pursuit of stability. The new era of extreme inequality that has derailed that progress since the 1980s, he shows, is partly a reaction against communism, but it is also the fruit of ignorance, intellectual specialization, and our drift toward the dead-end politics of identity. Once we understand this, we can begin to envision a more balanced approach to economics and politics. Piketty argues for a new participatory socialism, a system founded on an ideology of equality, social property, education, and the sharing of knowledge and power. Capital and Ideology is destined to be one of the indispensable books of our time, a work that will not only help us understand the world, but that will change it.

13 Cashing in on cyber power: how interdependent actors seek economic outcomes in a digital world / Peters, Mark T. -- The University of Nebraska Press: USA, 2018; xii, 268p.

The world has become increasingly digitally interconnected, military leaders and other actors are ditching symmetric power strategies in favor of cyberstrategies. Cyberpower enables actors to change actual economic outcomes without the massive resource investment required for military force deployments. Cashing In on Cyberpower addresses the question. Why and to what end are state and nonstate actors using cybertools to influence economic outcomes? The most devastating uses of cyberpower can include intellectual property theft, espionage to uncover carefully planned trade strategies, and outright market manipulation through resource and currency values. Offering eight hypotheses to address this central question, Mark T. Peters II considers every major cyberattack (almost two hundred) over the past ten years, providing both a quick reference and a comparative analysis. He also develops new case studies depicting the 2010 intellectual property theft of a gold-detector design from the Australian Codan corporation, the 2012 trade negotiation espionage in the Japanese Trans-Pacific Partnership preparations, and the 2015 cyberattacks on Ukrainian SCADA systems. All these hypotheses combine to identify new data and provide a concrete baseline of how leaders use cybermeans to achieve economic outcomes.

14 Caste: the lies that divide us / Wilkerson, Isabel -- Penguin Random House: UK, 52131 2020; xvii, 476 p.

This book tells about the caste system, Isabel Wilkerson gives us a masterful portrait of an unseen phenomenon in America as she explores, through an immersive, deeply researched narrative and stories about real people, how America today and throughout its history has been shaped by a hidden caste system, a rigid hierarchy of human rankings. Linking the caste systems of America, India, and Nazi Germany, Wilkerson explores eight pillars that underlie caste systems across civilizations, including divine will, bloodlines, stigma, and more. Using riveting stories about people--including Martin Luther King, Jr., baseball's Satchel Paige, a single father and his toddler son, Wilkerson herself, and many others--she shows the ways that the insidious undertow of caste is experienced every day. She documents how the Nazis studied the racial systems in America to plan their outcast of the Jews; she discusses why the cruel logic of caste requires that there be a bottom rung for those in the middle to measure themselves against; she writes about the surprising health costs of caste, in depression and life expectancy, and the effects of this hierarchy on our culture and politics. Finally, she points forward to ways we can move beyond the artificial and destructive separations of human divisions, toward hope in our common humanity.

15 Corporate social responsibility and sustainable development: strategies, practices and business models / Das, Jitendra K., Shallini Taneja, Hitesh Arora (ed.) -- Routledge: New York, 2021; xxi, 251p.

This book is critically analyzes the role of corporate social responsibility (CSR) in achieving sustainable development in emerging economies. This facilitates for a comparative study of the North Eastern Region with the Country. This book is mainly based on Census information and on some other relevant books and publications, and will perhaps help in knowing or understanding many of the untold or unknown stories of the North Eastern States and of the Region.

India accounts for large numbers of internally displaced people in the world. Apart from conflicts and disasters, over the years development projects (including urban redevelopment and beautification), often justified as serving the interests of the people and for public good, have caused massive displacements in different parts of the country, disrupting the lives and livelihoods of millions of people. The interdisciplinary essays presented here combine a rich mix of research methods and include in-depth case studies on aspects of development-induced

displacement affecting diverse groups such as peasants, religious and ethnic minorities, the poor in urban and rural areas, and women, leading to their exclusion and marginalization. The struggles and protests movements of the displaced groups across regions and their outcomes are also assessed.
