#### **Titles and Other Details**

1 Ancient glass of South Asia: Archaeology, ethnography and global connection/ 52293 Kanungo, Alok Kumar-- Springer: Singapore, 2021; xxvi, 557p.

This book provides comprehensive research on Ancient Indian glass. The contributors include experienced archaeologists of South Asian glass and archaeological chemists with expertise in the chemical analysis of glass, besides, established ethno historians and ethno archaeologists. It is comprised of five sections, and each section discusses different aspects of glass study: the origin of glass and its evolution, its scientific study and its care, ancient glass in literature and glass ethnography, glass in South Asia and the diffusion of glass in different parts of the world. The topic covered by the different chapters ranges from the development of faience to the techniques developed for the manufacture of glass beads, glass bangles or glass mirrors at different times in South Asia, a major glass-producing region and the regional distribution of key artefacts both within India and outside the region, in Africa, Europe or Southeast Asia. Some chapters also include extended examples of the archaeometry of ancient glasses. It makes an important contribution to the archaeological, anthropological and analytical aspects of glass in South Asia. As such, it represents an invaluable resource for students through academic and industry researchers working in archaeological sciences, ancient knowledge systems, biotechnology, historical archaeology, social archaeology and student of anthropology and history with an interest in glass and the archaeology of South Asia.

2 Azim Premji: the man beyond the Billions/ Khanna, Sundeep-- Harper Business: 52200 Uttar Pradesh, 2020; xxi, 225 p.

The book tells the story of the Azim Hasham Premji. He has been one of the trailblazers of India Inc. Taking over his family business of vegetable oils at the young age of twenty-one after the untimely demise of his father, he built one of India's most successful software companies along with a multi-billion-dollar conglomerate. As of 2019, he was the tenth richest person in India, with an estimated net worth of \$7.2 billion. Yet, the one facet of the man which has overshadowed even his business achievements is his altruism. His commitment to the Azim Premji Foundation, a non-profit focused on education, totals around \$21 billion, making him one of the world's top philanthropists. Azim Premji: The Man Beyond the Billions, the first authoritative biography of the icon, shows how Premji is a philanthropist at heart and a businessman by choice – a man who wanted to give away his billions but realized early enough that he would first have to earn them. It peels the layers off Premji's life while chronicling his professional and charitable work in the context of his many strengths and shortcomings. Based on interviews with hundreds of current and past Wipro executives, who have over the years worked closely with him, as well as with

competitors, analysts, family friends and industry associates, this is a journalist's account of Premji the man, the businessman and the philanthropist.

3 Beyond consumption: India's new middle class in the Neo-Liberal Times/ Jha, 52213 Manish K (ed.)-- Routledge: New York, 2022; xix,269p.

This book analyses India's middle class by recognising the diversity within the class, the people, their practices, and the production of spaces. It explores the economic and social lives of the new middle class, expanding the areas of inquiry beyond consumption in post-liberalisation India and its intersectionality with gender, caste, religion, migration, and other socioeconomic markers in various cities across the country. The book interrogates the meanings and perceptions of social mobility, growth, consumerism, technology, social identity, and development and examines how they can be emancipatory or subjugating in different contexts. It engages with the new entrants in the middle class, particularly from the marginalised sections, their struggles, insecurities, anxieties, agency, and experiences. The personal, emotive, and psychic dimensions of social mobility have been dealt with in the larger context of socioeconomic settings. The book crosses disciplinary and spatial boundaries and uses a variety of methodologies to provide perspectives on several unexplored or underexplored areas of India's new middle class. This book will be of interest to scholars and researchers of sociology, economics, development studies, public policy, social work, and South Asian studies.

4 Brand new nation: capitalist dreams and nationalist designs in twenty-first-century 52201 India/ Kaur, Ravinder-- Harper Business: Uttar Pradesh, 2021; xv, 346p.

The first book examines India's mega-publicity campaigns to theorize the global transformation of the nation-state into an attractive investment destination. The early twenty-first century was an optimistic moment of global future-making. The chief narrative was the emergence of the BRICS nations-leading stars in the great spectacle of capitalist growth stories, branded afresh as resource-rich hubs of untapped talent and potential, and newly opened up for foreign investments. The old third-world nations were rapidly embracing the script of unbridled capitalism in the hope of arriving on the world stage. If the tantalizing promise of economic growth invited entrepreneurs to invest in the nation's exciting futures, it offered utopian visions of "good times," and even restoration of lost national glory, to the nation's citizens. Brand New Nation reaches into the past and, inevitably, the future of this phenomenon as well as the fundamental shifts it has wrought in our understanding of the nation-state. It reveals the on-the-ground experience of the relentless transformation of the nationstate into an "attractive investment destination" for global capital. As Ravinder Kaur provocatively argues, the brand new nation is not a mere nineteenth-century re-run. It has come alive as a unified enclosure of capitalist growth and nationalist desire in the twenty-first century. Today, to be deemed an attractive nation-brand in the global economy is to be affirmed as a proper nation. The infusion of capital not only

rejuvenates the nation; it also produces investment-fueled nationalism, a populist energy that can be turned into a powerful instrument of coercion. Grounded in the history of modern India, the book reveals the close kinship between identity economy and identity politics, publicity and populism, and violence and economic growth rapidly rearranging the liberal political order the world over.

5 Child marriage in an international frame: a feminist review from India/ John, Mary 52281 E-- Routledge: New York, 2021; xv, 210p.

Child marriage has been given a pre-eminent place in agendas addressing "harmful practices" as defined by the United Nations Sustainable Development Goals. India leads the world in the number of women who marry below the age of 18 and is therefore of unique interest to international and national forums. Refusing simplistic labels like "harmful practice", this book explores the complex history of child marriage as a social and feminist issue in India across different domains. It critically reviews a wide range of historical, demographic, and legal scholarship on the subject. Major concepts relevant to child marriage - such as childhood, adolescence, the girl, and marriage - are analysed in a comparative framework that uncovers the unnoticed presence of the practice in the USA and China. The volume questions existing approaches, analyses the latest data sources, and develops a new concept of compulsory marriage A definitive study of child marriage in India in a changing global context, this book will interest scholars and students in the fields of women's, gender and sexuality studies, childhood studies, development studies and the social sciences. It will also be of great appeal to all those working with civil society organisations, NGOs, states and international agencies in India, and globally.

6 Climate change, livelihood Diversification and Well-Being: The case of Rural 52282 Odisha/ Mitra, Arup-- Springer Nature: Singapore, 2021; X, 107p.

We investigate whether spatial variations in climatic resources such as rainfall have prompted livelihood diversification, local adaptation and household food availability in Indo-Gangetic Plains using data from a household survey of 2660 farm families carried out in India, Bangladesh and Nepal. We found that on-farm livelihood sources are higher in high rainfall regimes (1300-1800 mm) compared to medium (<1300 mm) and very high rainfall regimes (>1800 mm). The off-farm sources are higher in the medium rainfall regime. Although a large number of changes are attributed to harvesting better yield, farmers made several changes in response to climatic variability as well. Although agricultural livelihood and local adaptation are restrained by several climatic and non-climatic factors; the amount of annual rainfall significantly affects livelihood diversification, and the impact of climatic stressors becomes more pronounced when there is interaction with other non-climatic factors. The results imply that livelihood and adaptation strategies should be tailor-made along the climatic and non-climatic resources.

7 Contested homelands: politics of space and identity/ Parveen, Nazima-- Bloomsbury 52209 Publishing India Pvt. Ltd.: Delhi, 2021; xxiii, 312p.

This book argues that the changing character of the Muslim community and their living space in Delhi is a product of historical processes. The discourse of homeland and the realities of Partition established the notion of 'Muslim-dominated areas' as 'exclusionary' and 'contested' zones. These localities turned out to be those pockets where the dominant ideas of the nation had to be engineered, materialized and practised. The book attempts to revisit these complexities by investigating the community-space relationship in colonial and postcolonial Delhi. It raises two fundamental questions: How did community and space relations come to be defined on religious lines? In what ways were 'Muslim-dominated' areas perceived as contested zones? Invoking the ideas of homeland as a useful vantage point to enter into the wider discourse around the conceptualization of space, the book suggests that the relationship between Muslim communities and their living spaces has evolved out of a long process of politicization and communalization of space in Delhi.

8 Culture and economic transformation: perspectives from India and China/ Surjit 52292 Singh(ed.)-- Rawat Publications: Jaipur, 2013; xi, 291 p.

This book explores the intersection of culture and economic development in India and China. Emerging horizons in India-Vietnam relations/ Sinha, Shakti(ed.) -- Pentagon Press: 52288
Delhi, 2018; xxix, 233 p.

This book focuses on the emerging contours of India-Vietnam relations in the backdrop of the enduring partnership between the two countries which has progressed and matured over the years. Though the diplomatic relations between these two countries are 46 years old, the relationship between India and Vietnam goes beyond this symbolic gesture of numbers. The historical, cultural and civilisational ties are profound. Internal synergies between India and Vietnam have played a significant role in bringing the two countries on the same page, building upon mutual trust and cooperation over the years. Given the cultural-religious linkages, based on their closer association with the historical kingdoms and the impact of Buddhist philosophy on the anti-imperialist struggle during the colonial rule and foreign intervention during the Second World War and thereafter, both the countries have developed closer ties and a shared destiny based on a shared world view.

Energy law and policy in India/ Bhat, Sairam(ed.)-- National Law School of India 52290

Husain, Prince Charles, Sanjay Gandhi and Ebrahim Alkazi, and behind-the-scenes history of major events in which he played a key role. Candid, enlightening and with doses of tongue-in-cheek humour, this book showcases Indian bureaucracy in a new light.

17 Gandhi: the years that changed the world 1914-1948/ Guha, Ramachandra-- Penguin 52203 Books: Haryana, 2018; xx, 1129p.

The book is a luminous portrait of not only the man himself, but also those closest to him—family, friends, and political and social leaders. Opening in July 1914, as Mohandas Gandhi leaves South Africa to return to India, the book traces the Mahatma's life over the three decades preceding his assassination. Drawing on new archival materials, acclaimed historian Ramachandra Guha follows Gandhi's struggle to deliver India from British rule, forge harmonious relations between India's Hindus and Muslims, end the pernicious practice of untouchability, and nurture India's economic and moral self-reliance. He shows how in each of these campaigns, Gandhi adapted methods of nonviolence that successfully challenged British authority and would influence revolutionary movements throughout the world. 18 Gilgit-Baltistan: and its saga of unending human rights violations/ Bansal, Alok-- 52291 Pentagon Press: Delhi, 2018; 291p.

This book is an attempt to lift the veil of ignorance about this region and make it a part of the national strategic dialogue. In a knowledge-driven world, ignorance is no bliss. Blatantly put, ignorance of facts is a curse that Nations and their people will pay for heavily in terms of security, strategy and overall handling of situations. India has faced many existential crises' over the years due to a lack of comprehensive information or misinformation, the most glaring being the Jammu & Kashmir issue. The common man is oblivious to a lot of critical information about Jammu & Kashmir including a region as strategic as Gilgit-Baltistan being a part of Jammu & Kashmir.

19 Glimpses of water management in rural India: a regional perspective/ Dubey, 52285 Anupama-- Academic Foundation: Delhi, 2019; 249p,

This book comprises five chapters. First chapter, based on secondary sources, elaborates on the contextual and conceptual aspects of water resource management. The remaining four chapters are based on primary data, collected in different years from different states of the country. The second and third chapters are assessments of water management at the community level, sourced from six sample districts of Telangana and Andhra Pradesh. The fourth chapter presents macro-level management of surface and groundwater in the Mirzapur district of Uttar Pradesh.

Grassroots innovation: minds on the margin are not marginal minds/ Gupta, Anil K.- 52204
Penguin Random House: Haryana, 2016; xv, 381p.

A moral dilemma gripped Professor Gupta when he was invited by the Bangladeshi government to help restructure their agricultural sector in 1985. He noticed how the marginalized farmers were being paid poorly for their otherwise unmatched knowledge. The gross injustice of this constant imbalance led Professor Gupta to found what would turn into a resounding social and ethical movement— the Honey Bee Network— bringing together and elevating thousands of grassroots innovators. For over two decades, Professor Gupta has travelled through rural lands unearthing innovations by the ranks—from the famed Mitti Cool refrigerator to the footbridge of Meghalaya. He insists that to fight the largest and most persistent problems of the world we must eschew expensive research labs and instead, look towards ordinary folk. Innovation—that oft-flung around the world—is stripped to its core in this book. Poignant and personal, Grassroots Innovation is an important treatise from a social crusader of our time.

21 Growth, disparities and inclusive development in India: Perspectives from the Indian 52278 state of Uttar Pradesh/ Mamgain, Rajendra P.-- Springer Nature: Singapore, 2019; xxix, 411p. The book suggests strategies for promoting high and sustained economic growth and highlights the significance of broadening social inclusiveness through greater and more rapid access to economic and social opportunities and building strong social safety nets to protect the chronically poor and mitigate their risks and vulnerabilities with the help of good governance and institutions. With contributions from leading scholars from the region, it is a valuable resource for researchers working in the area of growth and inequality, as well as for policymakers from developing economies around the globe.

22 Human Evolution, Economic progress and evolutionary failure/ Rao, Bhanoji-- 52286 Routledge: New York, 2017; x,131p.

This monograph is an innovative endeavour in many ways. First, it brings to the fore the synergy between human evolution and economic and social progress. Second, it acknowledges the critical contributions from the routine adherence to contextual truth and contextual non-violence of humanity at large. Finally, it argues that the world is sliding towards evolutionary failure by not moving further forward in adherence to the two core human values. For all those interested in development in a holistic sense, the book will inspire thinking and debate. Human evolution will go on - one way or the other - with or without adherence to truth and non-violence. The book stresses the time is now, to go for the best and eschew the worst.

23 India that is Bharat: coloniality, civilisation, constitution/ Deepak, J. Sai-- 52274 Bloomsbury: Delhi, 2021; xxiv, 460 p.

This is the first book of a comprehensive trilogy, that explores the influence of European 'colonial consciousness' (or 'coloniality'), in particular its religious and racial roots, on Bharat as the successor state to the Indic civilisation and the origins of the Indian Constitution. It lays the foundation for its sequels by covering the period between the Age of Discovery, marked by Christopher Columbus' expedition in 1492, and the reshaping of Bharat through a British-made constitution-the Government of India Act of 1919. This includes international developments leading to the founding of the League of Nations by Western powers that tangibly impacted this journey. Further, this work also traces the origins of seemingly universal constructs such as 'toleration', 'secularism' and 'humanism' to Christian political theology. Their subsequent role in subverting the indigenous Indic consciousness through a secularised and universalised Reformation, that is, constitutionalism, is examined. It also puts forth the concept of Middle Eastern coloniality, which preceded its European variant and allies with it in the context of Bharat to advance their shared antipathy towards the Indic worldview. To liberate Bharat's distinctive indigeneity, 'decoloniality' is presented as a civilisational imperative in the spheres of nature, religion, culture, history, education, language and, crucially, in the realm of constitutionalism.

24 India's power elite: class, caste and a cultural revolution/ Baru, Sanjaya-- Penguin 52206 Random House: Haryana, 2021; xvii, 243p.

India's Power Elite is a study of the nature of power and elitism in postcolonial India. Its point of departure is the political transition underway in twenty-first-century India, with the marginalization of the Congress Party and the staging of a cultural revolution symbolized by the rise of Hindu majoritarianism. Baru deconstructs the morphology of the Indian power elite-comprising remnants of a feudal gentry, kulaks, a metropolitan business class, the civil services and a cultural elite of opinion-makers. He also examines the role of caste, class and culture in the emergence of a 'New India'. Aimed at the socially engaged reader, this book will interest both students as well as those who wield power.

25 Making of a Hindu Patriot: Background of Gandhiji's Hind Swaraj/ Bajaj, J K-- Har- 52276 Anand Publications: Delhi, 2021; 1043p.

The book tells the story of the evolution of Hind Swaraj, the foundational text of Mahatma Gandhi, as a text of religious patriotism and Gandhiji as a Hindu Patriot, perhaps the greatest Hindu Patriot, Deshbhakta Mahatma, of our times. The story is told largely in his own words. Part II of the book compiles 388 extracts, mainly from the writings of Gandhiji from 1891 to 1909, that are relevant to this evolution. The introductory part, Part I, leads the reader through these extensive extracts to weave a connected story of the development of Gandhiji, his campaigns and his ideas during this period. The book graphically describes the story of the birth of Satyagraha in the historic meeting held at the Empire Theatre of Johannesburg on 11 September 1906. The extract entitled "The South African Jail Diary" offers a hair-raising account of the tortures that Gandhiji,b as also his family and followers, had to go through in the jails of a foreign land in the pursuit of Satyagraha. The book also documents the two farewell meetings of July 1914, held in Durban and Verulam on the eve of the departure of Gandhiji from South Africa, where Gandhiji was first formally addressed as Deshbhakta Mahatma. The title of "Hindu Patriot" comes from Leo Tolstoy, who deeply admired Gandhiji "except for his Hindu patriotism.

26 Managing cultural change in public libraries: Marx, Maslow and management/ 52218 Pateman, John-- Routledge: New York, 2019; xvi, 204 p.

This book argues that changes to library Strategies and Systems can lead to transformations in library Structures that can, in turn, shape and determine Organisational Culture.
