1 (IL)Logical Knowledge Management: A Guide to Knowledge Management in the 51451 21st Century/ Schertzer, Beverly Weed-- Emerald Publishing Limited: United Kingdom, 2020; xxi, 124p.

This book presents that in today's world, strategic knowledge management is a critical practice for all businesses seeking to protect their assets and produce intelligible and useable information. However, formally implementing a comprehensive knowledge management infrastructure to support an organization—enabling businesses to create, protect, and collaborate through knowledge—is often easier said than done. How do businesses adapt to the evolving challenges of knowledge management, and what best-practice tips are based on common misconceptions?

2 Capabilities, Innovation And Economic Growth: Policymaking for Freedom And 51421 Efficiency: Policymaking for Freedom And Efficiency/ Capriati, Michele--Routledge Taylor & Francis Group: New York, 2018; xi,250p.

This book explores the question of whether we can foster growth and innovation while promoting individual freedoms poses a challenge for everyone studying and working on innovation and development policies. Whilst innovation literature is largely dominated by a focus on efficiency, development literature tends to focus on equality and pays less attention to mechanisms fostering economic and social change. This book aims to move beyond these barriers and to identify development policies that foster both efficiency and equality, exploring the connection between innovation policies and the improvement of individual freedoms. Capabilities, Innovation and Economic Growth argue that we can answer these questions by focusing on the relation between Amartya Sen's human development approach and the Neo-Schumpeterian analysis of innovation systems. After considering the connections between the two schools of thought and the way they enrich each other's perspectives, chapters go on to show how policy can support virtuous circles in which innovation, human development and economic growth interact and mutually reinforce each other. This is undertaken through the descriptive analysis and the empirical testing of a sample of nations and European regions. The volume concludes with an exploration of the contribution that the capabilities approach can give to the design of innovation policy, and with the analysis of macroeconomic policies favourable to innovation and human development. This will be essential reading for: students and academic economists interested in development, growth and innovation; policymakers and officers in charge of defining development and innovation plans at the national and regional level; and consultants and managers in development agencies implementing innovation and development projects.

3 Chinese And Their Rebellions: View in connection with their National Philosophy, 51465 Ethics, Legislation, and Administration/ Meadows, Thomas Taylor-- Cambridge University Press: United Kingdom, 2015; Ix,656p.

This Content was inspired by the lectures in Munich of the German orientalist Karl Friedrich Neumann, Thomas Taylor Meadows (1815–68) devoted himself to the study of Chinese in 1841, intending to enter British service. He arrived in China early in 1843 and rose quickly to the post of a consular interpreter at the key treaty port of Canton (Guangzhou), where he remained for several years. His Desultory Notes on the Government and People of China, and on the Chinese Language (1847) is also reissued in this series. The present work, first published in 1856, is an expansive treatment of matters relating to 'the present Chinese rebellion', namely the Taiping Rebellion (1850–64). Meadows discusses the ongoing conflict within its historical and cultural context, offering also observations and recommendations on Anglo-Chinese relations. He closes with a lengthy disquisition on the nature and state of 'civilization' in the East and West.

4 Commanding Military Power: Organizing for Victory and Defeat on the Battlefield/ 51462 Grauer, Ryan-- Cambridge University Press: United Kingdom, 2016; 280, pp.

It describes Commanding Military Power offers a new explanation of why some armed forces are stronger than others. Ryan Grauer advances a 'command structure theory' which combines insights from organization theory, international relations, and security studies kinds of literature to provide a unique perspective on military power. Specifically, armed forces organized to facilitate swift and accurate perception of and response to battlefield developments will cope better with war's inherent uncertainty, use resources effectively, and, quite often, win. Case studies of battles from the Russo-Japanese War, Chinese Civil War and Korean War, based on new archival research, underscore the argument, showing that even smaller and materially weaker militaries can fight effectively against and defeat larger and better-endowed adversaries when they are organizationally prepared to manage uncertainty. That organization often matters more than numbers and specific tools of war has crucial implications for both contemporary and future thinking about and efforts to improve martial strength.

5 Creating Smart Cities/ Coletta, Claudio(ed.); Kitchin, Rob(ed.) and Evans, 51422 Leighton(ed.)-- Routledge Taylor & Francis Group: New York, 2019; xi,241p.

The book is about to tell about the cities around the world, digital technologies are utilized to manage city services and infrastructures, to govern urban life, to solve urban issues and to drive local and regional economies. While "smart city" advocates are keen to promote the benefits of smart urbanism – increased efficiency, sustainability, resilience, competitiveness, safety and security – critics point to the negative effects, such as the production of technocratic governance, the corporatization of urban services, technological lock-ins, privacy harms and vulnerability to cyberattack. This book, through a range of international case studies, suggests social, political and practical interventions that would enable more equitable and just smart cities, reaping the benefits of smart city initiatives while minimizing some of their perils. Included are case studies from Ireland, the United States of America, Colombia, the Netherlands, Singapore, India and the United Kingdom. These chapters discuss a range of issues including political economy, citizenship, standards, test-bedding, urban regeneration, ethics, surveillance, privacy and cybersecurity. This book will be of interest to urban policymakers, as well as researchers in Regional Studies and Urban Planning.

This book combines economic studies of innovation systems with studies of mediatisation, media convergence, trans- and cross-media and with other approaches within media and cultural studies. It elaborates on a new concept, cross-innovation, referring to co-innovation and convergence processes taking place between different sectors of digital service economies. The proposition is that digitisation and mediatisation processes are conditioning new inter-sector dialogues and the emergence of new cross-innovation systems at the borderlines of formerly distinct industries. The case study industries presented are, on the one hand, audiovisual media (film, television, videogames, etc.) and health care, education or tourism, on the other hand. The book builds on 2 years of empirical work across Nordic and Baltic countries, putting a special emphasis on the opportunities and challenges for small countries as they build the cross-innovation systems in the era of media globalisation and platform station of services. The empirical research of 144 interviews with stakeholders (policymakers, entrepreneurs, managers, professionals) from all four sectors and of secondary data and documentary analysis. The findings tell of complex stories how global platform station of tourism undermines the emergence of related cross-innovation systems in small countries; how the fragmentation of local education and health care markets does not enable the scalability of innovations but protects local innovation systems from being overtaken by global platform giants. It presents that consolidation activities such as mergers and acquisitions (M&As) have been one of the major strategies adopted by Indian firms to withstand global competition. M&As experienced a substantial increase in value and volume during the post-liberalization era, facilitated by the presence of foreign subsidiaries in the Indian market as well as competitive pressure on domestic firms. The increased foreign investment through M&As brought new dimensions to the fore such as the implications on technological performance, efficiency, and more importantly, competition in the Indian market. The Globalisation of Indian Business: Cross Border Mergers and Acquisitions in Indian Manufacturing provides an in-depth analysis of these issues, specifically aiming to understand whether the M&As strategies helped the firms to achieve their desired objectives in terms of improvement in technology, efficiency and market power in the context of the increase of M&As in India, using appropriate statistical and econometric techniques. The book is of additional importance in the context of the recently implemented Competition Act, replacing the thirty-year-old MRTP Act in India. The new Act aims to maintain competition and protect consumers' interests without harming the producers. Based on the analysis, broadly, the study cautions the regulators to rethink the efficiency defence argument and become more vigilant on the creation of monopolies. On the other side, it suggests firms should reconsider their post-merger integration strategy since consolidation has not led to a sustainable increase in the market share of the surviving firms.

19 Good Life Beyond Growth: New Perspectives / Rosa, Hartmut(ed.) and Henning, 51433 Christoph(ed.)-- Routledge Taylor & Francis Group: New York, 2018; xvii,270p.

The book covers many countries that have experienced a decline in economic growth for decades, an effect that was only aggravated by the recent global financial crisis. What if in the 21st century this is no longer an exception, but the general rule? Does an economy without growth necessarily bring hardship and crises, as is often assumed? Or could it be a chance for a better life? Authors have long argued that money added to an income that already secures basic needs no longer enhances well-being. Also, ecological constraints and a sinking global absorption capacity increasingly reduce the margin of profitability on investments. Efforts to restore growth politically, however, often lead to reduced levels of social protection, reduced ecological and health standards, unfair tax burdens and rising inequalities. Thus it is time to dissolve the link between economic growth and the good life. This book argues that a good life beyond growth is not only possible but highly desirable. It conceptualizes "the good life" as a fulfilled life that is embedded in social relations and at peace with nature, independent of a mounting availability of resources. In bringing together experts from different fields, this book opens an interdisciplinary discussion that has often been restricted to separate disciplines. Philosophers, sociologists, economists and activists come together to discuss the political and social conditions of a good life in societies that no longer rely on economic growth and no longer call for an ever-expanding circle of extraction, consumption, pollution, waste, conflict, and psychological burnout. Read together, these essays will have a major impact on the debates about economic growth, economic and ecological justice, and the good life in times of crisis.

20 Grand Strategy and Military Alliances/ Mansoor, Peter R and Murray, Williamson. 51463 (Con)-- Cambridge University Press: United Kingdom, 2018; 411, pp

Book tells about alliances that have shaped grand strategy and warfare since the dawn of civilization. Indeed, it is doubtful that the United States of America would have gained its independence without its Revolutionary War alliance with France. Such alliances may prove even more important to international security in the twenty-first century. Economic and financial difficulties alone will ensure that policymakers attempt to spread the burden of securing vital interests onto other nations through alliances, both formal organizations such as NATO and informal alliances of convenience as developed to wage the Gulf War in 1991. A team of leading historians examine the problems inherent in alliance politics and relationships in the framework of grand strategy through the lens of history. Aimed at not just the military aspects of alliances, the book uncovers the myriad factors that have made such coalitions succeed or fail in the past.

21 Indian Agriculture After The Green Revolution: Changes And Challenges: 51429 Changes And Challenges/ Goswami, Binoy(ed.); Bezbaruah, Madhuriya Prasad(ed.) and Mandal, Raju(ed.)-- Routledge Taylor & Francis Group: New York, 2018; xv,233p.

It describes a country plagued with chronic food shortage, the Green Revolution turned India into a food-grain self-sufficient nation within the decade of 1968-1978. By contrast, the decade of 1995-2005 witnessed a spate of suicides among farmers in many parts of the country. These tragic incidents were symptomatic of the severe stress and strain that the agriculture sector had meanwhile accumulated. The book recounts how the high achievements of the Green Revolution had overgrown to a state of this 'agrarian crisis'. In the process, it also brings to fore the underlying resilience and innovativeness in the sector which enabled it not just to survive through the crisis but to evolve and revive out of it. The evidence is clear: the benefits of possessing nuclear weapons are almost exclusively defensive, not offensive
