Scope of Work & Additional Terms & Conditions and Scope of Works for SITC of Retro-fit Emiss ion Control Device (RECD) on the D.G. Sets capacity 180 KVA & 200 KVA of ICSSR, New Delhi.

A. Scope of Work:

The scope of work under this inquiry covers all directly or indirectly related works for SITC of Type tested r etro-fit emission control device (RECD) on existing D.G. Sets 180 KVA & 200 KVA such as:

- 1. Estimation and design of suitable holding structure and foundation of RECD, control panel and its sub-syst ems in consultation with ICSSR after site visit and study of existing DG set and its surroundings at ICSSR Campus, New Delhi.
- 2. Design, Manufacture, Supply, Installation, Testing and Commissioning of Type Test approved Emission Co ntrol Device on existing DG sets of 180 KVA Cummins make 200 KVA Kirlosker make having engine model: respectively as per latest DPCC/NGT/CPCB notification / MoHUA recommendations to achieve minimum sp ecified particulate matter capturing efficiency.
- 3. Proper finishing including covering for safety and environmental protection, painting etc as required for pr oper functioning and maintenance of the engine and RECD.
- 4. DG Set emission testing at site before and after installation of RECD from any NABL accredited laboratory and submission of reports.
- 5. Providing all test certificates, drawings and operating manual of RECD and associated items, if any.
- 6. Providing maintenance manual of RECD and required consumables (if any) for same for a minimum runnin g of 500 Hrs.
- 7. All works including civil, electrical, mechanical etc. are under scope of work of this Contract. Nothing extra other than the quoted rate shall be paid by ICSSR.

B. Additional Terms & Conditions:

1. Supply, Installation, Testing, Commissioning and Training as per scope of works, is to be carried out by Ty pe Test Approved OEM / OEM Certified resource or OEM authorised Reseller only.

OEM must have CPCB1 Type Approval certificate from CPCB Accredited Labs

- 2. **Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid , Bid specific Authorisation Form /Certificate of OEM/Original Service Provider details such as name, design ation, address, e-mail Id and Phone No. required to be furnished along with the bid.
- 3. The bidders have to submit their offers in two parts as Technical Bid and Price Bid. In Technical Bill the bid ders have to submit following:
 - i) Manufacturer's certificate/ Bid specific authorization certificate from the Manufacturer.

- 4. The Bidder is advised to visit and examine the installation site and its surroundings and gather all informa tion that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder
- 5. Retro fit emission control device for DG set should have Type Approval Certificate from any of the followin g CPCB approved laboratories:
 - i. Automotive Research Association of India, Pune (Maharashtra)
 - ii. International Centre of Automotive Technology, Manesar (Haryana)
 - iii. Indian Institute of Petroleum, Dehradun (Uttarakhand)
 - iv. Vehicle Research Development Establishment, Ahmednagar (Maharashtra)

Type Test Certificate of the product shall be submitted along with the technical bid.

6. Retro-fit emission control device should be confirming to latest DPCC/NGT/ CPCB notification / MoHUA rec ommendations to achieve minimum specified particulate matter capturing efficiency of at least 70%. The particulate matter shall be tested at site first without the device on DG during a continuous operation of 2 Hours with 50-70 % load. Thereafter it will be measured after installation of retrofit emission control device during a continuous operation of 2 Hours with 50-70 % load. From the test results particulate matter capturing efficiency of at least 70% to be achieved.

Emission control device should achieve the norms specified by Commission for Air Quality Management vi de their notification no. F.No. A-110018/01/2021-CAQM/827(DT) dated 02-06-2023, related to this and F.No . A-11018/01/2021-CAQM/5322-15331 dated 29.09.2023 and subsequent orders.

- 7. The RECD should have no effect on exhaust back pressure of the engine. The back pressure of the engine shall be maintained within prescribed limit of the engine manufacturer.
- 8. The installation of RECD should not have any adverse effect on the engine power producing capacity.
- 9. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary informati on with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bi d.
- 10. **Time of Completion:** Completion time for the all the works as per scope of work shall be **90 days** from t he date of issue of Purchase Order/ date of submission of performance security. The time shall be the esse nce of this contract and entire work as titled above is to be completed in all respects within a period of 90 days. Any delay in completing the work for reasons attributable to the Contractor is liable for liquidated da mages as per clause 8 of Additional Terms & Conditions. However, under the force-majeure conditions, ICS SR may grant suitable time extension without penalty for which the contractor has to request along with th e justification/ reasons well in advance to ICSSR for approval without any prejudice to price escalation. No time extension request shall be considered after the expiry of completion period. The decision of the Mem
